## Mobile Tubs – General Terms and Conditions

- MASTER AGREEMENT:** The Lessee (as listed on Page 1 of this Rental Agreement) and Lessor (Mobile Tubs) acknowledge and agree that the terms and conditions contained in this agreement shall govern the rental of any and all equipment by the Lessee from the Lessor, and the term "Equipment" as used herein shall refer to all such equipment. Except as otherwise expressly agreed by the Lessor and Lessee in writing, in the event of a conflict between the terms and conditions contained in this agreement and any terms or conditions set out in any purchase order, acceptance or other document the Lessee and Lessor agree that the terms and conditions set out in this agreement shall govern.
- THE RENTAL PERIOD:** The rental period with respect to the Equipment shall commence on and include the day of actual delivery of the Equipment to the Lessee. The rental period shall end on and include the day of Equipment pickup by the Lessor. The Lessee is responsible for the Equipment until it has been removed from the Lessee property. Rental rates are based on rate schedule on Page 1 of this agreement.
- PAYMENT:** The Rentals due under this Lease shall be paid in full either in advance to the mailing address of the Lessor at the address designated on Page 1 of this agreement or on day of delivery of Equipment to Lessee by the Lessor. Lessor reserves the right to deny delivery of Equipment in the event of failure to pay the Rental by the Lessee.
- INSPECTION:** Before the Equipment is delivered to the Lessee, the Lessor shall inspect and clean Equipment to ensure its satisfactory condition for operation. If the Lessee does not inspect the Equipment upon delivery, then the Lessee is conclusively deemed to have accepted that the Equipment is in good condition and working order, without broken or worn out parts, and in clean and unmarred condition.
- MAINTENANCE, OPERATIONS AND REPAIRS:** The Lessee shall not remove, alter, disfigure or cover up an numbering, lettering or insignia displayed upon any Equipment, and shall ensure that no Equipment is subjected to careless or needlessly rough usage, and shall, at the Lessee's own expense, maintain and ultimately return to the Lessor the Equipment and its appurtenances, together with any tools and accessories pertaining thereto, the whole in good repair and operating order.
- LOSS OF OR DAMAGE TO EQUIPMENT:** The Lessee shall indemnify and hold harmless the Lessor against all loss and damage to the Equipment during the rental period and the appraisal for any such loss or damage shall be based on the replacement cost of Equipment without deduction for depreciation. The Lessee will be liable for all resulting loss or damage to the Equipment and expense of the Lessor, to the extent it:  
(i) results from the gross negligence of the Lessee which includes, but is not limited to, the use or operation of the Equipment in a reckless or abusive manner, or intentional damage to the Equipment by the Lessee or by Lessee's permission, or (ii) occurs under either of the following circumstances:  
A. All loss or damage associated with vandalism, malicious mischief, theft or conversion of the Equipment.  
B. All loss or damage associated with Equipment being overloaded, operated above rated capacity or if operating instructions are not followed.
- LIABILITY OF LESSEE:** The Lessee shall indemnify and hold harmless the Lessor against all loss, expenses, penalties, damages, condemnations and legal costs which the Lessor may suffer or may be required or condemned to pay for personal injuries (including death) and/or property damages suffered by any person by reason of the Equipment or the operation, handling, transportation or use thereof by or while in the hands of the Lessee. The Lessee shall remain responsible for the Equipment until it has been returned to the Lessor. The Lessee shall maintain at the Lessee's own expense, public liability and all risk property insurance in adequate amounts to fully cover this indemnity. The Lessee hereby renounces all claims which he (it) may have against the Lessor for any loss or damage which he (it) may suffer, either directly or indirectly, by reason of the condition of the Equipment or its suitability for the operation it may be required to perform.
- TITLE:** Title to the Equipment shall at all times be and remain vested in the Lessor and nothing contained in this Lease shall be deemed to have the effect or conferring upon the Lessee any right or title whatsoever in or to the Equipment, other than that of Lessee. The Lessee shall not incur or permit to exist any lien or other encumbrance on or with respect to the Equipment. The Lessee shall give the Lessor immediate notice in case any of the Equipment is levied upon or from any cause becomes liable to seizure.
- SUBLETTING AND LOCATION:** None of the Equipment shall be sublet by the Lessee, nor shall he (it) assign or transfer any interest in this Lease without the previous consent of the Lessor. The Equipment shall be used only at the location where delivered to by Lessor.
- WARRANTIES:** Lessor makes no warranties, either express or implied, as to any matter whatsoever, including, without limitation, the condition of the Equipment, its merchantability or fitness for a particular purpose, or that it is suited for the Lessee's intended use. The aggregate liability of Lessor hereunder, if any, shall be limited to the amount paid to it by Lessee under this Lease. This Lease represents the entire agreement between the parties with respect to the Equipment. Lessor reserves the right to refuse service to any person(s) without warning, reason or cause at any time.

## Mobile Tubs – Safety Information

- Never allow water to exceed 40°C (104°F).
- Limit soak time to 15 minutes at a time.
- Use a buddy system when using hot tub and avoid using alone.
- Do not allow children to use the hot tub without supervision and limit soak time to 10 minutes at a time and/or reduce tub temperature.
- Never allow anyone who has been drinking alcohol or using any kinds of drugs (prescribed or illegal) to enter the hot tub.
- Never go under water in a hot tub due to the risk of hair entanglement in suction and subsequent drowning hazard.
- Persons with heart disease, diabetes, high or low blood pressure, any serious illness, pregnant women and any persons with any doubt should not enter a hot tub without prior consultation with a physician.
- Persons with skin, ear, genital, or other body infections should not enter the hot tub because of the possibility of spreading the infection.
- Do not operate any electrical device within 10 meters of hot tub. Electrical shock or electrocution can occur in a hot tub if live electrical current (including current from a telephone) comes into contact with the water. Use a ground fault circuit interrupter (GFCI) on any appliance that must be near the hot tub.
- You or your guests will most likely be barefoot while near the hot tub. Use only unbreakable dishes, beverage containers, and utensils around hot tub and never use glass anywhere near or in the hot tub. Broken glass is invisible in water and extremely difficult to get out of the water circulation system.
- To avoid a slip fall injury be sure to have a towel nearby to properly dry feet before walking in or out of hot tub. Where possible hot tub should be placed on a non-slip surface.
- Never use hot tub during a thunderstorm or when lightening is occurring in your area.
- When not in use always have cover on hot tub and locked to prevent unsupervised child access and potential drowning hazard.
